Suddenly, my white butterfly swoops down and circles my head!


In today's readings, we learn much about our God --- Who He is and what kind of relationship He wants to have with each of us. Isaiah tells us: "Seek the Lord while He may be found. Call Him while He is near...turn to the Lord for mercy." God wants us to search for Him. He is not hiding way up there. He is right here. His spirit lives within each of us. All we need do is call out to Him. He will hear and answer us.

In the second reading from Paul. The writer tells us that he would rather depart from this life and be with Christ; but yet He stays with the people whom God has asked him to serve. He stays because they need him. I know how Paul feels. I long to be with Jesus, my husband Gene and my grandson Chris. Until Jesus comes for me though, I must and will remain with those who need me.

The Gospel according to Matthew is most reassuring. At first glance, the landowner seems to be unjust to the workers who toiled all day. Those who labored but one hour receive the same reward as they do. At times, we may worry about a loved one who seems to be at a distance from God. We pray that he may grow closer to Jesus. Unexpectedly, this loved one is taken from our midst. Like the Good Thief dying beside Jesus at Calvary, Jesus is also with him. At the moment of his death, he recognizes Jesus --- his heart overflows with love. Jesus takes him in his arms and tells him: "This day you will be with Me in paradise!" Is this the meaning of Jesus' words: "The last will be first and the first and the first will be last".



WEEKLY READINGS

God's Ways and Ours

Today's gospel always reminds me of my Dad. He was a daily communicant and placed great value on justice and treating everyone fairly. He couldn't fathom how Jesus could tell the story of a vinedresser who paid two people the same amount when one worked all day and the other, just a few hours! He was an electrical engineer and worked for 35 years for Minneapolis Honeywell in Sacramento, bidding on hospital and school jobs in Northern California and Nevada. If he didn't get the contract, he wouldn't have advanced in the company.

He exclaimed to me once, many years ago: "You've given your whole life to God and given up a lot. Why should someone who does whatever he wants, lives a wild life, and only changes right before he dies, get the same reward you do? It's not fair!" His comment made me think. It occurred to me that an unspoken assumption underneath his reasoning was the sense that trying to live a good life is really difficult and makes one unhappy, while doing whatever one wants to equals a happy life.

I wouldn't trade my life for anyone's, though obviously there are some fulfilling aspects of life that I've missed, like being married and having children. I've had the joy of sharing in many people's joys and sorrows, of being trusted with the stories of their lives. I've had the satisfaction of doing something with my life which makes a difference, though a small one, to many people. I've had more time than those of you with family responsibilities to pray and pay attention to God's presence in my life and, hopefully, to help you to pay attention to God's presence in your life, too! I daresay I've had a happier life than many people who have lived only for themselves. So many "rich and famous" people, envied by others, seem to go through one major crisis after another.

Isn't it just like our loving and merciful God to welcome into heaven someone who has missed the experience of living a truly human life of relationship with God and with others? And, of course, the eternal life we're all promised isn't really a reward anyway. It is a free gift, offered to everyone. All we have to do is to receive it and, if we're fortunate to be believers, to begin living that life with God now.



Conscience Rights Violated by Sweeping HHS Contraceptive Mandate

In implementing the 2010 Patient Protection and Affordable Care Act (the new health care reform law), the U.S. Department of Health and Human Services (HHS) recently issued a rule *requiring* almost all private health plans to cover contraception and sterilization as "preventive services" for women. The mandate even forces individuals and groups with religious or moral objections to purchase and provide such coverage if they are to receive or provide health coverage at all. This poses an *unprecedented threat* to individual and institutional religious freedom.

The rule includes a religious exemption so extremely narrow that it protects almost no one. It covers only a "religious employer" that has the "inculcation of religious values" as its purpose, primarily employs and serves persons who share its religious tenets, and is a church organization under two narrow provisions of the tax code. A great many religious organizations -- including Catholic colleges and universities, as well as hospitals and charitable institutions that serve the public -- will be ineligible. Individuals and religiously affiliated health insurers will not qualify for the exemption.

The new rule would force insurance plans to cover "all Food and Drug Administration approved contraceptive methods, sterilization procedures, and patient education and counseling for all women with reproductive capacity." Never before has the federal government required private health plans to include such coverage. The FDA-approved "emergency contraception" (EC) drugs that are covered by this mandate can work by interfering with implantation of a newly conceived human being. Also, the drug the FDA most recently approved for EC, "Ella," a close analogue to the abortion drug RU-486, has been shown in animal tests to cause abortion. Thus, the mandate includes drugs that may cause an abortion both before and after implantation.

The public comment period on this interim final rule ends September 30.

ACTION: Please send an e-mail message to HHS by visiting <u>www.usccb.org/conscience</u>. Once you send your comments to HHS, you will be automatically invited to send a message to your elected representatives in Congress, urging them to support the Respect for Rights of Conscience Act (H.R. 1179/S. 1467) to ensure that such federal mandates do not violate Americans' moral and religious convictions.

MESSAGE TO HHS: "Pregnancy is not a disease, and drugs and surgeries to prevent it are not basic health care that the government should *require* all Americans to purchase. Please remove sterilization and prescription contraceptives from the list of 'preventive services' the federal government is *mandating* in private health plans. It is especially important to exclude any drug that may cause an early abortion, and to fully respect religious freedom as other federal laws do. The narrow religious exemption in HHS's new rule protects almost no one. I urge you to allow all organizations and individuals to offer, sponsor and obtain health coverage that does not violate their moral and religious convictions."
